



Silicon PIN Photodiode

Description

BPV20F is a high speed and high sensitive PIN photodiode in a plastic package with a cylindrical side view lens. The epoxy package itself is an IR filter, spectrally matched to GaAs or GaAs/GaAlAs IR emitters (λ_p =950nm).

Lens radius and chip position are perfectly matched to the chip size, giving high sensitivity without compromising the viewing angle.

In comparison with flat packages the cylindrical lens package achieves a sensitivity improvement of 20 %.

- Wide viewing angle $\varphi = \pm 65^{\circ}$




Figure 1. Reverse Dark Current vs. Ambient Temperature




Figure 2. Relative Reverse Light Current vs. Ambient Temperature




Figure 3. Reverse Light Current vs. Irradiance




Figure 4. Reverse Light Current vs. Reverse Voltage




Figure 5. Diode Capacitance vs. Reverse Voltage




Figure 6. Relative Spectral Sensitivity vs. Wavelength





Figure 7. Relative Radiant Sensitivity vs. Angular Displacement





